PSO Romblon hands over Community-Based Monitoring System (CBMS) Data to Five Municipalities of Romblon

RSSO MIMAROPA holds Press Conference on the January 2024 Inflation



MIMAROPA delivered a statement on the inflation report. He enumerated key observations from the report of RD Rioflorido, also adding details to the causes of uptrend or downtrend of inflation rates in the provinces and highly urbanized city in the region. He also mentioned some steps taken by the various agencies in the government cited in the Regional Development Plan 2023-2028, such as continuous improvement of the supply chain logistics and other non-monetary measures.

The Philippine Statistics Authority Regional Statistical Services Office (RSSO) MIMAROPA conducted the Press Conference on January 2024 Inflation of the MIMAROPA Region on 08 February 2024 in Calapan City, Oriental Mindoro via hybrid conferencing.

Inflation rate refers to the annual rate of change or the year-on-year change in the Consumer Price Index (CPI) expressed in percent. Inflation is interpreted in terms of the declining purchasing power of money. Meanwhile, the CPI is an indicator of the change in the average retail prices of a fixed basket of goods and services commonly purchased by an average Filipino household. It shows how much on the average, prices of goods and services have increased or decreased from a particular reference period known as the base year.

Regional Director (RD) Leni R. Rioflorido presented the January 2024 Inflation citing that the headline inflation rate at the regional level decelerated to 3.6 percent in January 2024, from the 4.4 percent inflation in the previous month.
