21 FEBRUARY 2025 – ROMBLON, ROMBLON. The Romblon Provincial Statistics Committee (RPSC) successfully convened its 1st Quarter 2025 Regular Meeting at Conference Hall, Capitol Building, Brgy. Capaclan, Romblon, Romblon on 20 February 2025. Facilitated by Philippine Statistics Authority (PSA)-Romblon Provincial Statistical Office, in collaboration with Provincial Planning and Development Office (PPDO) of Romblon, the meeting was chaired by PGDH-PPDO Willard B. Mortos, EnP, MNSA, the RPSC Chairperson.

Topics being presented and given appropriate discussion during the meeting includes Updates on the 2024 POPCEN-CBMS, 2024 Provincial Product Accounts, PhilSys Updates, January 2025 Inflation Report, Proposed Activities for the National Women's Month, Latest Vital Statistics Data Appreciation, and PSA-LGU Data Sharing Project.
